2. Call to order- **Linda Griffith acting as Secretary** as Cindy Welch could not be at the meeting.
3. Minutes of the previous meeting in Sevierville, TN, approved earlier/no further action required.

Treasury Report: Dick advised that Ricky Keen and Linda Culbertson are working together to affect the changeover of Treasurer information and duties. They have experienced some difficulty with Wells Fargo in making the transfer. They expect to accomplish the transfer shortly with Ricky continuing to fill duties in the interim.

Discussion regarding possible future site locations for Camp Discovery/SE Region Rally after our contract with LazyDays runs out and after our rally on January 23-29, **2023**. Discuss this under National Rally Master info later on in the meeting. Contract will be discussed.

Update on status of SW Region chapters. Bruce Plumb, the new SW Region VP, has been and is actively working with all the issues here.

1. **New Four Corner chapter under Van Edelman with about 18 coaches is working on By-Laws to formally form the chapter.**
2. **D'Zonas Chapter has folded** and closed, lost membership and no one to keep it going.
3. **California Discoverys Chapter** closed. The President who was also the former SW VP sold his coach and purchased a non-Discovery coach. No one was willing to step up to become chapter officers to keep it going after many calls and discussions.
4. All individual members who still own their Discovery are encouraged to remain as DOAI members and consider joining another chapter.

Update on status of Frank Miller's effort to establish the on-line tech library for our Discovery coaches. Frank reported that REV is working to develop an on-line website for online tech library. Vintage Coaches 1997-2000 and coaches 2001-2016 or 2017. The website is <https://revrvparts.com>.

Bill Johnson, President of Fleetwood Motorhome Assn and also a DOAI member, gave an update on REV. REV is working on build sheets for technical information on our coaches. Go to <https://revrvparts.com> and put in last 7 digits of your coach to get your build sheets. This information should be put on the forum and newsletter.

Appointment of Mel Pless as South-Central Vice President.

1. **Seek a motion for BOD to concur** with the appointment of Mel Pless to succeed Harry Bruton who had to resign from position due to health reasons.
2. Mel Pless has agreed to take the position over from Harry Bruton.
3. Motion made from John Ricciardi and seconded by Frank Miller. All in favor and motion carried.

Approval to add the position of Camp Discovery Coordinator as a non-voting member to the Board of Directors and receive rally reimbursement. Currently this is Kerry Pinkerton.

1. Camp Discovery is a major DOAI activity and is of substantive importance to the organization.
2. The coordinator position needs to interact with the BOD at a formal level where he/she can be involved with the overall Board matters as they affect Camp Discovery.
3. A motion was made by John Ricciardi to name Kerry Pinkerton as **National Technical Coordinator for Major Rallies**. The motion was Seconded by Glenn Magnuson. Vote was unanimous in favor.

Executive Vice President John Ricciardi – John met with chapter Presidents. John informed them that we would like to see the DOAI website kept up to date. Need chapters to update DOAI website for Officers and rallies.

President Dick Tracy- Suggested the Webmaster have assistance by appointing one or two people to review and keep the status of information on the website updated and feed changes to our Webmaster. Also, a discussion was held concerning a request to park members more closely together for Camp Discovery. This will be looked into.
2. Fred wants to discontinue the PayPal option for future SE Region Rallies. Just pay with a check and mail it to the registrar. Brief discussion ensued. No motion made.
3. Blue Ridge Chapter will host the next (2023) Camp Discovery at Lazydays – Arrival date January 30, departing February 5, 2023.
4. **Discussion held regarding possible future site locations for Camp Discovery/SE Region Rally** after our contract with Lazy Days runs out after our rally on January 23-29, 2023. **Many favor continuing at Lazydays, no decision made.**

Some of the topics presented at Camp Discovery include the 12 volt systems (batteries, chargers, distribution, control), the 120 Volt systems (30 and 50 amp pedestal power, generators, inverters), heating and cooling systems, plumbing, slide-outs, levelers, and how to service/maintain the chassis (engine, transmission, brakes, generator). The topics covered all Discoveries from 1997 to the present, including the latest technology such as Aqua-Hot and FireFly.

If you missed Camp Discovery, we are planning to provide an updated version at the SE Region Rally in Seffner next year so book your reservation early so that you don't miss out!

Technical Library and REV Owners Portal

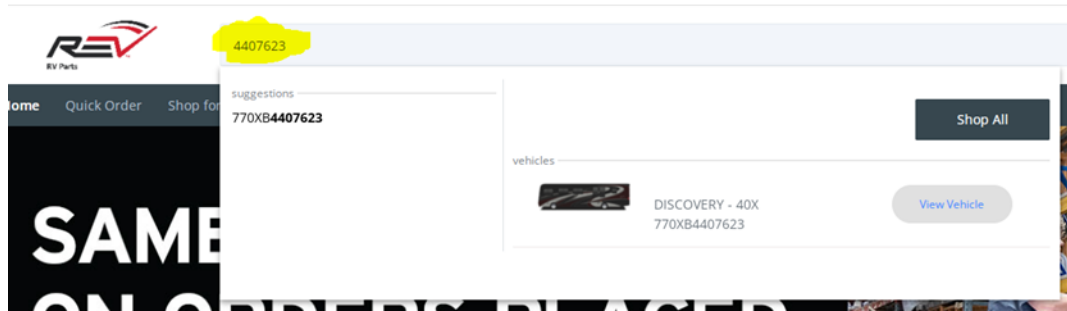
DOAI Technical Library Update

Following the 2021 National Rally, we have been researching the practicality of creating a DOAI technical library of Discovery Documents that could be easily accessible by our members. These year and model specific documents would cover the Electrical, Plumbing and Structural **Technical Drawings** as well as the **Components and Parts** installed in our coaches by Fleetwood/REV. Particularly for coaches prior to 2008, much of documentation was not in a digital format. To access these drawings, a REV employee would need to locate the correct document in a warehouse of hundreds of thousands and scan it in order to download it for a customer.

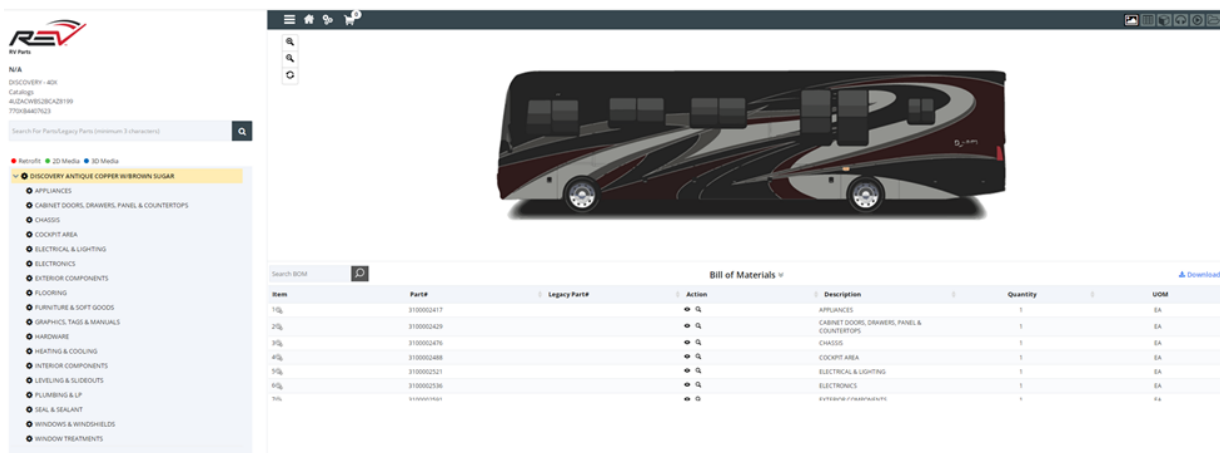
Currently, for documents already in a digital format, the **Basic Drawings** can be obtained by going to <https://www.fleetwoodrv.com/contact-us/> (or calling Customer Service at 800-322-8216) and with your Fleetwood Identification Number (FIN) and Vehicle Identification Number (VIN). You can request the Electrical, Plumbing, and Structure drawings for your coach. If available, you should receive the most 20-30 commonly needed PDF drawings by eMail. If you need any of the less common drawings you can request those but you'll need to identify the specific item needed.

Parts and Components installed in your RV can be found by going to <https://revrvparts.com/> and entering the last 7 digits of your VIN (or your FIN) on the top line of the web page. Your Coach with the correct FIN and VIN should display.

DOAI Technical Library Update Continued



Click View Vehicle to access the Build Sheet for your coach to see the following:



On the left hand side you can select the area in the coach you are interested in and drill down to get specific parts. Under the Action column, the “eye” icon will get you full details, the “magnifying glass” may tell you where that item is used, and the “cart” icon will tell you if the item is available.

The REV Owner Portal – REV is working to finalize an Owners Portal which will give owners access to electrical, plumbing, and structural type drawings for the year and model of a Coach. Coach specific drawings will be available, by VIN or FIN, where proper documents exist.

Given the massive effort being put forward by REV and the impact to volunteer labor needed to build and maintain a DOAI Technical Library, we will be directing requests for technical documentation to the REV resources at the current time.

One of the most valuable DOAI resource available for answers to your coach specific issues and questions are the forums available by going to <http://www.discoveryowners.com/egroup.asp>. The forum for the Technical Support is <https://groups.io/g/discoveryowners>. There is also a Lifestyle Forum for the non-technical discussions. The folks on the forum range from newbies to extremely knowledgeable members that willingly address questions and issues across all years of Discoveries and their installed components.

Another extremely valuable resource for live education is Camp Discovery held each year at the South East Region Rally in late January in Florida.

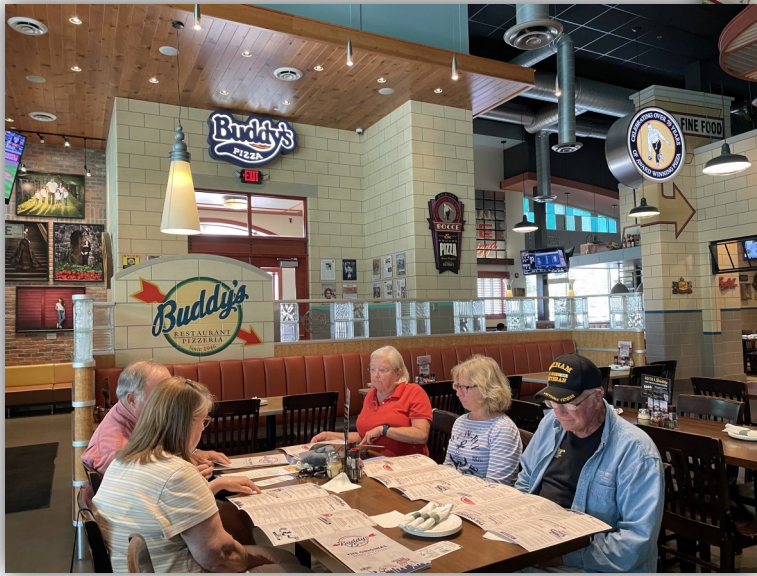

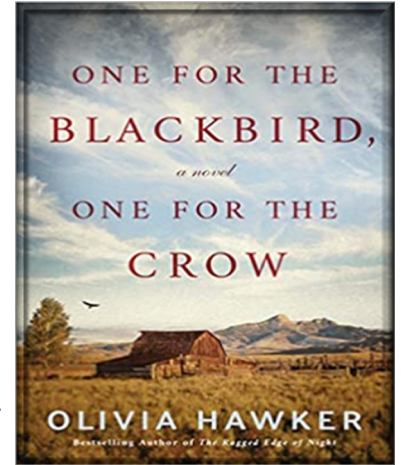
Hello Readers:
