## RALLY UPDATES:

VP Leydic asked Frank Cason to provide the chapter with an update on the Spring 2019 BRD Rally, Spring 2020 BRD Rally, and the FALL 2020 DOAI National Rally.

Frank reported the <u>BRD Spring 2019</u> rally is scheduled for April 28, 2019 to May 5, 2019 at River Plantation RV Resort in Sevierville, TN. He said he will be sending out the registration forms. The sites will be \$38.50+ tax per day for non-river sites and \$41.50+ per day for river sites. BRD will have access to the pavilion. DOAI 2020 FALL NATIONAL RALLY hosted by BRD is scheduled for September 29, 2020 to October 4, 2020. Frank said Early Arrival is set for September 26, 2020. There are 125 sites that are reserved. Bob Angus will be the Rally Master for this rally.

## **Furniture Fest**

The DOAI rally in Goshen, IN turned into a Furniture-Fest for several BRD members!

Tom & Katy Leydic traveled to Shipshewana in July to furniture shop. They ordered a sofa from Lambright Comfort Chairs, and new captains's chairs from Bradd & Hall. They arranged for installation of their sofa to be done during the rally. The captain's chairs would be installed by BRD members at the campground during the rally. They ordered power footrests on both chairs, and Bradd & Hall said they could not legally install a chair with a footrest in the driver's chair position. They could sell them, but not install them.

Mike and I had already planned our own shopping trip, and when we learned that Tom & Katy were already there, I talked with Katy and she told me what stores we should check out. We arrived a week later and went shopping. We ended up ordering the same style sofa they had selected, also from Lambright. We ordered a credenza, dining table, and chairs, to replace our U-shaped dinette, from Bradd & Hall.

We arrived back in Shipshewana in late August for the installation of our new dining furniture. We love it! The table is free-standing, so we can pull it out into the middle of the floor, and use all 4 sides for seating. With the 12" extension leaf, it is 48" long, much larger than our old table, and we love the new chairs!

Shortly after arriving in Goshen, for the DOAI rally, Tom & Katy got their new sofa, and ours was installed a few days later. The sofa we both got has dual wall-away full recliners. The back of the center section folds down to make theater seating, with cup holders, table area, and phone charger. It also has electronic reclining controls, and electric adjustable headrest. There is really no comparison to the old furniture! This sofa is extremely comfortable! Just about everyone who came to see them said, "I have to have one of these!".

The installation of the Tom & Katy's captain's chairs proved to be more challenging than expected. But after several trips to the hardware store, the use of some power tools, and persistence, they finally got the first chair installed, and the  $2^{nd}$  one went in more easily the following day. They are SO comfortable!!

A few days after our sofa was installed, Rick & Diana Blaher went to Lambright to look at new furniture for their coach. They ended up purchasing the floor model of the same sofa that we and the Leydic's purchased, and were able to get it installed right away.

Just before the end of the rally, Mike Weiher drove over to Lambright to see what he could find for his coach. He picked a little bit different style as the rest of us, since he needed a shorter sofa for his space. As it turned out, they had the sofa he wanted, in the color he had chosen, in stock. He delayed his departure by 1 day, got his new sofa installed Monday morning, and then drove the 8 hours, straight through, to the BRD rally in Bowling Green.

# Water System Modification

Recent water system modification on my 2015 Discovery 40E. It has simplified our setup procedures by eliminating setting up the water softener, water pressure regulator and water filter. Now they are built in and all we need to do is hook up the water hose. As you can see in the photo, the water hose is connected by use of a quick connect going first to an adjustable water pressure regulator, then using Shark Bite PEX fittings and tubing, it goes to a water filter mounted with a T-connector with valve to provide water to the Sami-Flush. No more separate hose connection needed. From the water filter it goes to the water softener, that is now mounted. It can be disconnected easily to remove when time to regenerate. From the water softener the water now feeds to the water inlet connection into the house plumbing system. This modification is an awesome change to our motorhome. I must give all credit and thanks to Frank Cason who did this project.



# FOR THE COOK

## TWICE BAKED POTATOES

(8 halves)

## Ingredients:

4 large baking potatoes
8 slices of bacon
1 cup sour cream
1/4 - 1/2 cup milk
4 Tbs. butter
1/2 tsp. salt
1/2 tsp. pepper
1 cup shredded cheddar cheese, divided
8 green onions, sliced and divided



## **Preparation:**

Preheat oven to 350 F., Bake potatoes in oven for 1 hour Or microwave for about 12 minutes after poking holes in potatoes so they don't explode. They should be tender. If not, nuke for an extra minute or two.

While baking, place bacon in large, skillet and cook over MEDIUM-HIGH heat until evenly browned. Drain, crumble, and set aside.

When potatoes are done, let cool for 10 minutes. Slice in 1/2 lengthwise, and scoop flesh into a large bowl, leaving about 1/4" of flesh in skin so potato retains it's shape; save skins. To the potato flesh, add sour cream, salt, pepper, 1/2 the cheddar cheese, 1/2 the green onions, and milk. Start with 1/4 cup, but add more to get the consistency you desire. You don't want it too runny. Mix with hand mixer until smooth and creamy. Spoon mixture back into potato shells and top with bacon, remaining cheese, and onions.

Bake in oven for another 15-20 minutes at 350 F.

Prep time 30 minutes. Cook time 60 minutes (or 12-15 in microwave). Great side for chicken, beef or pork.
