# Chapter Formation

June 5, 2004, was a damp, cool day at Candy Hill Campground, Winchester VA, when a group of Discovery owners met to consider forming a new chapter of DOAI. It is a day many in the world remember for a very different reason. Late in the afternoon, eastern time, we heard the news that Ronald Reagan passed away at his home in Bel Air, California.

Those present at Candy Hill were DOAI founders Jim and Dorothy Devine, Dick and Sue Smith, Marshall and Becky Godwin, Cliff and Pam Gordon, Ron and Alice Kiebler, Marshall and Louise Mauck, and Arlene Richie. We came because Dick Smith wrote letters and made calls to get enough folks together who were interested in starting a new chapter.

The initiative to start this chapter began six months earlier. While attending the Southeastern Region Rally at Lazy Days in January, 2004, Dick expressed the need for a DOAI chapter to serve the general mid-Atlantic area. He was encouraged by Jim Devine, and Phil Yovino, at that time DOAI President, to begin the process to form a chapter.

Dick accepted the task and later received the addresses of area Discovery owners from MaryAnn Crowell, at that time DOAI Membership Chairman. One hundred and sixty-six letters were mailed to potential chapter members. Of the 27 responses, approximately 20 couples indicated they would like to see a chapter formed. The positive response created confidence that an area DOAI chapter could be successfully formed.

The meeting was called to order at 10:10am. The question was raised as to whether those potential members present desired to form a chapter. The affirmative response was unanimous. Dick indicated the steps necessary to do that were to elect officers, determine the chapter name, establish dues and approve the by-laws. It was decided to proceed with election of officers. Those chosen by unanimous vote were, Dick Smith, President; Marshall Godwin, Vice President; Becky Godwin, Secretary; Arlene Richie, Treasurer; and Ron Kiebler, Wagon Master.

We adopted the by-laws and established annual dues. The chapter name decision was delayed to give folks time to consider the submitted suggestions. The meeting was suspended to gather for lunch at Cassman's restaurant. During lunch a series of votes were taken to narrow down the recommendations and finally select the chapter name.

So, the Mason-Dixon Discoverys chapter was born almost 14 years ago. It is worthwhile to note that some of those founding members have since passed away. I know they loved the RV adventure and the people they met through membership in DOAI and our chapter. Let's keep the chapter active and fun in their memory.

## JACK DANIEL'S SAUCE

### Ingredients:

1. 1 head minced garlic
2. 1 Tbs. olive oil
3. 2/3 cup water
4. 1 cup pineapple juice
5. 1/4 cup Teriyaki sauce
6. 1 Tbs. soy sauce
7. 1 1/3 cups dark brown sugar (Stevia/Splenda)
8. 3 Tbs. lemon juice
9. 3Tbs. minced white onion
10. 1 Tbs. Jack Daniel's whiskey
11. 1 Tbs. crushed pineapple
12. 1/4 tsp. cayenne pepper



### Preparation:

1. In a medium saucepan, combine water, pineapple juice, Teriyaki sauce, soy sauce, and brown sugar over MEDIUM-HIGH heat. Bring to a boil, stirring occasionally, then reduce the heat to a LOW SIMMER.
2. Add the garlic and whisk to combine.
3. Add remaining ingredients to pan and stir.
4. Let the mixture simmer for about 45 minutes, until sauce is reduced by half, and is thick and syrupy. REMEMBER, LOW SIMMER. Do not let mixture boil over.

### Notes:

1. Great on chicken, (think wings, breasts, drumsticks, dipping sauce for nuggets) fish and veggies. Possibilities are endless!
2. Store, in covered container, in refrigerator until ready to use.

## Pasta Salad

(4 Servings)

- Uncooked pasta
- 1 tablespoon oil
- 3 tablespoons basic dressing (try Zesty Italian)
- 1 medium sized onion
- 12 black olives to garnish
- 1 tablespoon fresh herbs (chopped Parsley or other)



Cook the pasta in fast boiling salted water with 1 Tablespoon oil. Do not over-cook

Pour into a colander and rinse with cold water to stop further cooking.

Drain and mix with the salad dressing straight away.

Peel and finely chop the onion, stone and slice the olives.

Stir all these into the pasta and sprinkle the chopped parsley over the top.

You can also add other ingredients such as green peppers, asparagus, cucumbers, tomatoes
